## MAJIC 107.7'S "REMOTE DRAWING" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station **KMAJ-FM** ("Station"), 825 S. Kansas Ave, Topeka, KS 66612, during available business hours Monday through Friday, on the Station website **www.kmaj.com**, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the MAJIC 107.7'S "REMOTE DRAWING" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, plus residents in the following Kansas counties are also eligible: Atchison, Leavenworth Douglas and Franklin, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 14 days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 14 days or a prize valued at \$500 or more in the last 180 days. Void where prohibited by law. Employees of Station Cumulus Broadcasting LLC, and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and stepparents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

- 2. **Contest Period.** The Contest entry period begin at 11:00am CST on October 19, 2024, and will run through 1:00pm CST on October 19, 2024. (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.**

Remote Broadcast: Attend a remote broadcast conducted by Station on October 19, 2024, from 11:00am through 1:00pm at Cable Dahmer of Topeka, 3731 SW Topeka Blvd, Topeka, KS 66609 and send a text message with the designated keyword given on-site and spelled correctly, to 877-297-1077.

OR

<u>Free Alternate Method of Entry:</u> To enter the Contest without sending a text message during the remote broadcast, participants can visit the website <a href="https://amoe.textgroove.com/2c2f1e42-0857-4937-ab65-3c37a1835e8e">https://amoe.textgroove.com/2c2f1e42-0857-4937-ab65-3c37a1835e8e</a> and fully complete the Entry Form by (a) providing the keyword(s) spelled correctly (b) a telephone number (cell phone or landline), including area code, (c) email, (d) city, state, and zip code, and (e) name.

Limit one (1) entry per person per remote broadcast. All entries must be received by the deadline stated at the remote broadcast.

Texting in the Entry will not improve a Participant's chances of winning. Limit one (1) entry per person per remote broadcast, regardless of the method of entry chosen by a listener. Each remote broadcast, listeners may either (i) text in an entry into using a mobile device or (ii) enter online, but not both methods.

- 4. Winner Selection. On or about [10:00am] on October 21, 2024, Station will select one (1) potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
- Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 5. IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST.
