MAJIC 107.7'S "MERRY FLIPMAS" CONTEST OFFICIAL RULES

Kansas Ave, Topeka, KS 66612, during available business hours Monday through Friday, on the Station website **www.KMAJ.com**, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the MAJIC 107.7's "Merry Flipmas" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Entries must be received within 20 minutes of the switch to Christmas on November 21, 2024, to be a valid entry and eligible to win. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.

Texting in the Entry will not improve a Participant's chances of winning. Each Contest Round of the Contest, listeners may either (i) text in an entry into using a mobile device or (ii) enter online, but not both methods.
