MAJIC 107.7'S "SANDWICH PARTY TRAY" CONTEST OFFICIAL RULES

The Station will conduct the MAJIC 107.7's "SANDWICH PARTY TRAY" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 3. How to Enter.

Online: Visit the Station's website www.kmaj.com during the Contest Period, click on the "Contest" link, click on the Goodcents Giveaway Contest link and complete an entry form. All entries received by 11:59pm on March 16, 2025, will be eligible for the random drawing for the prize. Limit one (1) entry per person per Contest Period, regardless of how many email addresses a person may possess and use. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to submit more than one (1) entry by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry, and the entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. On or about 10:00am on January 6, 2025 and January 22, 2025, February 3, 2025 and February 19, 2025, March 3, 2025 and March 17, 2025 throughout the Contest period, Station will select six (6) potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the Facebook post provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
